The following items were discussed in the public session:

1. Some confusion existed over the notices given of the public consultation on the new Local Development Plan being carried out under the Neighbourhood Consultation banner. This had been copied out on email to all councillors but not generally posted through residents doors as appeared to be the intent. Concern was expressed at areas of land in Doddinghurst being designated for Housing development. Cllr Parker stated that the initiative stemmed from directives from the previous government and that targets for new builds in Brentwood had been cancelled. Councillors were encouraged to visit one of the events if they missed the one held in Doddinghurst on the 11th May 2011. (NB It was subsequently learnt that the proposers of land for development were residents and organisations from the village itself and not based on proposals stemming from Brentwood Council.)
2. Cllr Parker advised that a date for discussing All Saints Church path had been set.
